Meeting Minutes:

Day 1- October 21st

- Terry Clay, Hudson Advisors, is seeking input from everyone you don't have to be a member of the sub committee
- Currently only 10 customers are represented on the Portal subcommittee skewed if only certain customer participate
- Previously the committee was focused on prioritizing the existing enhancements list Future focus on new enhancements
- What do you want to see?
 - o Reserve disbursement widget
 - Create a Reserve disbursement widget (TJ had a prototype for this)
 - Integrate Borrower Inquiry and Inspections, Process Manager
 - Request can be kicked off in Borrower Inquiry
 - Approval process similar to functionality in Budget
 - Automate the creation of Strategy Transactions
 - Rules/Trigger to monitor Reserve Balances
 - o Trigger functionality
 - Release 17.8 customers would need to request it to be turn on
 - 48 canned triggers but can add to it
 - Works with rules engine
 - o Is there a plan to move CS module to the Portal?
 - Yes this is the long term plan but there is an interim plan to just have Strategy accessed through the web first
 - Emails Ability
 - Email generated when a task is generated we did this with Budget
 - Individual preference for those that don't want to work out of the Portal
 - We would need requirements on this
 - Widget Shape
 - Can widgets be made square we did this is past code probably still there
 - SOFR Change
 - Mapping Tool for ARM module so updates can be made in bulk

- Interim release will handle SOFR requirements
- Widget Test Color
 - Ability to change the color of the text on a Widget if you use a light color for the Widget
- o Hide the side bar to maximize the what you see
 - This happens when you open a widget within the Portal not in a new window
 - In R20, there will be a new default, when a widget is opened it will be opened in a new window to optimize view
- More Mapping Tools
 - Customer can see what is pending on the Work in Process list posted on the website
- o Job Status Widget
 - Need more visibility into pending jobs
- How are other customers utilizing the Portal
 - Platform to share ideas
