- Real Time Feed from FEMA.gov
  - Disaster Types, Dates, Locations
  - Sortable/Exportable
- Joins via County to Strategy properties
  - Drill down to view affected properties & loan/insurance information

#### Integrations – Disaster Resolution Tools

- Process Manager
  - Start Process for one or more affected properties
- Letter Writing
  - Send Borrowers customized letters "Request of Property Damage"
- Insurance Compliance
  - View active Coverages across one of more affected Properties
  - Holistic view of disaster impact
