#### **McCracken University in 2021**



## **Release Update**



Denise Ross reminded everyone of the content on the McCracken website. This is where you can see information about MAC Subcommittees as well as the Work in Process list. Denise pointed out that prior to a release being finalized, you can also review the Work in Process list to review content slotted for a release.

Release 19F was primarily changes to support Compounding in Arrears for SOFR as well as a few Year-End changes related to 1099 reporting. It is available from support now. At the 2020 Customer conference I made note that vulnerability patching as it relates to releases would become more prominent and you can see that with both Release 19E and Release 19F that vulnerability patching is part of the release.

Release 20 is targeted for end of 1<sup>st</sup> quarter. One item that may impact that timeline is that we are facing end of life for WebSphere, the operating system that the Portal and Portal apps run on. To get ahead of this we are testing and plan to deploy Release 20 using a new Webserver application, Liberty. This change will be transparent to our hosted customers, but will require us to test both Liberty and the new release thoroughly.
