#### Meeting Minutes:

Review of last meetings summary and follow ups - the last subcommittee meeting was held 2/10/2021.

## Follow-Up from 2/10/2021 Meeting:

#### Customers:

- Jason Kamienski from Berkadia was not on the call. Denise Pappu sent him an email reminder to research Jobs 16841 & 19758: what is the priority on 16841 and is 19758 still valid.
- Penny from Key Bank stated they've reduced the number of different bill cycle codes so they
  haven't experienced the issue reported under Job 20649 in a while. Agreed that job can be
  voided.

#### McCracken:

- Joan researched Job 16841 and is waiting for response from Jason from Berkadia. For Job 20237
   Denice answered Joan's first list of questions. Joan will writeup her additional loan level questions so we can discuss those on the next call scheduled for June 9th.
- Karla tested Job 21036 in Release 19D and R20 and did receive the message that the sum of the current certificate balances does not equal the Pool Principal Balance. Roxanne thinks it was the pro rata share error message that they didn't receive. Wells will submit example when this issue occurs again so Karla can recreate the scenario.

- Karla is still waiting to receive the GinnieMae construction pool reporting scenarios from
  customers. These must be received and reviewed before additional calls can be scheduled to
  discuss these requirements and the accounting entries.
- Karen will have a writeup of the missing investor transfer scenarios on the website next week. Also, provide update on delivery of these jobs and if any of them will be in R20.

#### New Investor Items:

• Karla mentioned she had a call with GinnieMae to discuss some possible fields being added to the RFS Reporting File. She is waiting for them to respond to some questions on some of the proposed fields. Anticipate the memorandum to be released Fall 2021. Proposed additions would require both front end and back-end Strategy changes. Mentioned we should have at least 6 months to implement the changes after the memorandum is released. Roxanne confirmed that they are allowed to accept and process principal curtailments on the multifamily pools. Karla will provide updates on this topic.

#### Create A Check;
