Meeting Minutes:

Review of last meetings summary and follow ups - the last subcommittee meeting was held 4/14/2021.

Follow-Up from 4/14/2021 Meeting:

Customers:

- Jason Kamienski from Berkadia will research Jobs 16841 & 19758 and will let us know the priority on 16841 and whether 19758 is still valid.
 - o Update: 19758 is no longer valid.
 - o 16841 Jason is working on priority with the requesting business unit.

McCracken:

Joan will verify she has everything she needs for Jobs 16841 – waiting for Jason's input. For Job 20237 - Joan sent BRD to Denise and will have it published on the website on Friday. Denice requested the BRD include purging orphan records where the collateral record has already been purged. This could be a precursor step. It would also be nice to have a report to show the orphan record. Business Requirements document is available is available on the McCracken Advisory Council page under General/Investor Reporting Committee>General Subcommittee Meeting Minutes.

- Karla will ask Wells Fargo if they've encountered the pro rata share error message issue for Job 21036. Wells will need to submit example when this issue occurs again so Karla can recreate the scenario.
- Karla is still waiting to receive the GinnieMae construction pool reporting scenarios from customers. These must be received and reviewed before additional calls can be scheduled to discuss these requirements and the accounting entries. Justin at Capital One asked to be contacted to go over the details of the documentation.
- Karla received an email from GinnieMae regarding the RFS Expanded Data Collection (Loan Level) file. Currently, they are proposing to add 13 new loan level data elements. Proposed additions would require both front end and back-end Strategy changes. The anticipated APM Issuance Date for the changes is November 2021. Thereafter, ample time (usually 6 to 9 months) for testing and adjustment time will be provided and communicated to all Issuers. Actual timeframe and considerations are not available currently. They requested that further questions be reserved until Ginnie Mae communications and the APM are released. Justin from Capital One is going to reach out to their GNMA representative to discuss the additional loan level fields and timing for implementing them. Denise will follow up with Roxanne & Lawrence.
- Karen had the writeups of investor transfer scenarios added to the website in April. MAC General Subcommittees <u>Investor Transfer Scenarios and Topics April 14, 2021</u>, is available on the McCracken Advisory Council page under General/Investor Reporting Committee>Investor Enhancements>Investor Transfer>Investor Transfer General Documents & Requirements. Customers should review the documentation to let us know if they need to provide additional scenarios and/or issues. If nothing received in next couple months, MFS should proceed with the project.
